#### **RE: Truth and Reconciliation Calls to Action**

At the meeting held on December 8, 2021, Council of the Township of Mulmur passed the following resolution regarding the Truth and Reconciliation Commission's Calls to Action.

#### Moved by Boxem and Seconded by Cufaro

WHEREAS the Truth and Reconciliation Commission released 94 Calls to Action to redress the legacy of residential school and advance the process of reconciliation;

AND WHEREAS the Council of the Corporation of the Township of Mulmur has reviewed the Calls to Action directed at municipal government;

NOW THEREFORE BE IT RESOLVED THAT Council of the Corporation of the Township of Mulmur take the following actions to address the Truth and Reconciliation Commission's Calles to Action directed at municipal government;

- THAT Council supports the implementation of Jordan's Principal;
- THAT Council permanently waives administrative fees related to name changes and revision of official documents for residential school survivors;
- THAT Council requests an update from the Central West Local Health Integration Network and Headwaters Health Care Centre to provide an update on the steps taken to address the Truth and Reconciliation Commission's Call to Action #23 and encourage cultural competency training for all healthcare professionals in Dufferin County be completed by the end of 2022;
- THAT Council further calls for the Ontario Government to take action on addressing the Truth and Reconciliation Commission's Call to Action #23;
- THAT Council requests an update from the Caledon Dufferin Victim Services on the steps taken to address the Truth and Reconciliation Commission's Call to

Action #40 to create adequately funded and accessible Aboriginal-specific victim programs and services in Dufferin County;

- THAT Council further calls for the Ontario Government to take action on addressing the Truth and Reconciliation Commission's Call to Action #40, specifically making these programs and services available within Aboriginal communities;
- THAT Council calls upon the Ontario Government to take action on the Truth and Reconciliation Commission's Call to Action #43 and move forward with passing Bill 76, the United Nations Declaration on the Rights of Indigenous People Act;
- THAT Council commits to ensuring that Mulmur's policies and bylaws do not rely on the colonial concepts of terra nullius;
- THAT Council commits to providing the National Council for Reconciliation, annual reports and current data as requested;
- THAT Council commits to providing skill-based training and/or information sessions including but not limited to intercultural competency, conflict resolution, human rights and anti-racism for all elected officials, residents and staff of the Township of Mulmur;
- THAT Council requests an update from the Dufferin Peel Catholic School Board and Conseil Scolaire Catholique MonAvenir on the steps taken to address the Truth and Reconciliation Commission's Call to Action #64;
- THAT Council recognizes the recent funding and commitment made by the Ontario Government to address the Truth and Reconciliation Commission's Calls to Action #62 and #63 and urges the Ontario Government to also address the Truth and Reconciliation Commission's Call to Action #64 by including curriculum on comparative religious studies in denominational schools;
- THAT Council further their commitment to commemorating the legacy of residential schools and honouring residential school survivors by annually recognizing September 30<sup>th</sup> as the National Day for Truth and Reconciliation;
- THAT Council open the first Council meeting in September each year with a moment of silence to pay respect to the innocent lives lost within the Canadian Residential School system;
- THAT Council direct staff to work in collaboration with the Dufferin County Cultural Resource Circle to encourage Dufferin County residents to share their

stories with the National Centre for Truth and Reconciliation, Mulmur Township and local libraries;

- THAT Council direct staff to request educational materials from the Museum of Dufferin, Indigenous Sport & Wellness Ontario, and/or other applicable agencies for distribution to Mulmur residents telling the national story of Aboriginal athletes in history;
- THAT Council direct staff to amend the Community Grant Policy to include a section to support Aboriginal athletic development/growth and support for the North American Indigenous Games and encourage the Ontario Government to provide financial support;

THEREFORE IT FINALLY BE RESOLVED THAT this motion be forwarded to the Premier of Ontario, Ministry of Health and Long-Term Care, Ministry of the Attorney General, Ministry of Indigenous Affairs, Ministry of Education, Caledon Dufferin Victim Services, Central West Local Health Integration Network, Headwaters Health Care Centre, Local Libraries, Dufferin Peel Catholic School Board, Conseil Scolaire Catholique MonAvenir, Dufferin Caledon MPP Sylvia Jones, Dufferin County and all Ontario municipalities.



**AND WHEREAS** all in-person appearances scheduled in municipally-administered Provincial Offences courts and all Provincial Offences Act appeals to a judge of the Ontario Court of Justice were adjourned until January 22, 2021;

**AND WHEREAS** the backlog of cases along with extreme lack of judicial resources has caused rolling closures of POA courts and in turn hearing cancellations with no availability to secure and reschedule dates in the foreseeable future;

**AND WHEREAS** these closures have inevitably caused delays in a number of prosecutions making it difficult to move matters forward at appropriate speeds;

**AND WHEREAS** these delays have had a significant impact on the Town's ability to initiate court action and move toward compliance on several serious enforcement matters including zoning infractions;

**AND WHEREAS** 276 parking infraction notices are awaiting trial and are expected be cancelled due to these delays in the POA courts which will result in significant revenue loss to the Town as the courts have indicated parking trials will not resume until in person hearings can recommence which is not anticipated for another full year;

#### **Recommendation:**

#### **Purpose of this Staff Report:**

The purpose of this Staff Report No. 63-21-BOD is to seek the Board's approval on the Authority's *Conservation Authorities Act* Transition Plan, which is a mandatory requirement. Also mandatory is that the transition plan be circulated to member municipalities and the Ministry of the Environment, Conservation and Parks (Ministry) and be available publicly on the Authority's website.

#### **Background:**

The passage of Regulation 687/21 "Transition Plans and Agreements for Programs and Services Under Section 21.1.2 of the Act" requires the development of a transition plan by each conservation authority. A Transition Plan should outline the approach and timelines for the development of cost apportioning agreements with municipalities within each conservation authority's jurisdiction for programs and services that fall into Categories 2 and 3 as defined in the Regulation.

The transition period runs from October 2021 to January 1, 2024, providing conservation authorities and municipalities the necessary time to address changes to the budgeting and levy processes, and in some cases, the need to establish agreements.

Each conservation authority is required to develop and submit its Transition Plans to the Ministry, with copies to member municipalities before December 31, 2021.

Attached to this report is this Authority's *Conservation Authorities Act* Transition Plan with key reporting dates and timelines associated with core tasks. The Transition Plan includes extensive mandatory reporting, which will be beneficial to the Board and watershed municipalities.

#### **Issues:**

The Authority has already commenced with early-stage elements of the transition plan process and will be aggressively addressing key elements in 2022. The Authority is well positioned as significant work completed over the past few years is complementary to the legislative requirements, along with work undertaken to harmonize service delivery areas where possible with neighboring conservation authorities.

Potential issues may arise as the transition plan is implemented, but these are difficult to fully foresee at this point in the process. The only principal challenge that is currently foreseen is the potential changes in Board member composition post the upcoming municipal election. Staff will ensure to include detailed overview and training regarding the *Conservation Authorities Act* amendments as part of the 2023 Board Orientation.

#### **Relevance to Authority Policy:**

There is no direct relevance to Authority policy as this Board report only addresses a transition plan and schedule.

#### **Impact on Authority Finances:**

There is impact associated with Authority finances as implementing the transition plan and all associated activities, agreements and budget processes will result in a new budget format for fiscal 2024.

#### **Summary and Recommendations:**

The Authority is well positioned to implement the *Conservation Authorities Act* Transition Plan over the next two years. Early work has already begun with a full slate of activities occurring quickly in 2022.

It is therefore **Recommended That** Staff Report No. 63-21-BOD regarding the Lake Simcoe Region Conservation Authority's *Conservation Authorities Act* Transition Plan be received; and **Further that** the Lake Simcoe Region Conservation Authority *Conservation Authorities Act* Transition Plan be approved; and **Further that** the Transition Plan be circulated to Ministry of

### **Lake Simcoe Region Conservation Authority**

#### Transition Plan in accordance with the Conservation Authorities Act

December 2021

#### **Purpose**

The *Conservation Authorities Act* requires conservation authorities to prepare Transition Plans outlining steps and timelines for the preparation of an Inventory of Program and Services and for the development and execution of funding agreements with participating municipalities. The Lake Simcoe Region Conservation Authority (Authority) Transition Plan sets out the process and timelines for the development and execution of memorandums of understanding (MOUs) and/or agreements between the Authority and municipalities to fund programs and services that are not deemed to be provincial mandatory core services outlined in the *Conservation Authorities Act* and associated regulations.

#### **Transition Plan**

The following lays out steps to be taken by the Authority and associated timelines to develop and enter into funding agreements with partner municipalities for non-mandatory programs and services at the request of a municipality with municipal funding through a MOU and programs and services an authority determines are advisable where municipal funding is needed.
