Re: LAKE SIMCOE

Dear Minister Freeland:

On behalf of the Council of The Corporation of the City of Barrie, I wish to advise you that on April 11, 2022, City Council adopted the following motion:

22-G-067 LAKE SIMCOE

- WHEREAS** Lake Simcoe is one of Ontario's largest watersheds, home to First Nations since time immemorial, and situated in the growing communities of Simcoe County, York Region, Durham Region, and the cities of Barrie and Orillia; and
- WHEREAS** the watershed faces threats due to eutrophication, largely from phosphorus runoff and other contaminants into the lake and its tributaries; and
- WHEREAS** the lake is a significant source of drinking water, as well as being integral for local recreation, tourism, agriculture and other key economic drivers; and
- WHEREAS** the previous federal government funded a "Lake Simcoe Clean-Up Fund" of \$65 million over 10 years between 2007-2017, but that fund has not been renewed; and
- WHEREAS** during the 2019 federal election, the Hon. Chrystia Freeland committed \$40 million over 5 years towards Lake Simcoe; and

- WHEREAS** during the 2021 federal election, the Liberal Party of Canada committed to “Implement a strengthened Freshwater Action Plan, including an historic investment of \$1 billion over 10 years. This plan will provide essential funding to protect and restore large lakes and river systems, starting with the Great Lakes-St. Lawrence River System, Lake Simcoe...”; and
- WHEREAS** the Conservative Party of Canada also committed to re-funding the Lake Simcoe Clean-Up Fund in the 2019 and 2021 general elections with an investment of \$30 million over five years; and
- WHEREAS** further to the Minister of the Environment and Climate Change’s mandate letter, which directs the Minister to “...establish a Canada Water Agency and implement a strengthened Freshwater Action Plan, including a historic investment to provide funding to protect and restore large lakes and river systems, starting with the Great Lakes-St. Lawrence River System, Lake Simcoe...”.

NOW THEREFORE BE IT RESOLVED that the Corporation of the City of Barrie:


- 1) Supports federal funding for a Lake Simcoe Restoration Fund that represents a significant percentage of the overall Freshwater Action Plan Fund, with funding in excess of previous commitments, beginning in the 2022 budget; and
- 2) Asks that such funding be used to undertake:
 - Shoreline mitigation, stream restoration and stormwater quality management, including in the tributaries of Sophia Creek, Kidd’s Creek, Bunkers Creek, Dyments Creek, Hotchkiss Creek, Whiskey Creek, Lovers Creek, and Hewitts Creek; and
 - Projects to ameliorate contaminated sites in the watersheds; and
 - Upgrades to help retrofit municipal infrastructure such as wastewater treatment and stormwater management facilities to decrease total current discharges from existing facilities; and
 - The planting of 250,000 trees in the watershed and purchasing and conservation of more forests and wetlands under the auspices of the Lake Simcoe Region Conservation Authority (LSRCA), to make significant progress towards the Lake Simcoe Protection Plan goal of 40 per cent of the watershed area being protected natural land.

- 3) That a copy of this resolution, along with a letter from the Mayor, be sent to the federal Minister of Finance, the Minister of the Environment and Climate Change, the President of the Treasury Board, the Members of Parliament for Barrie-Springwater-Oro-Medonte, Barrie-Innisfil, Simcoe-North, York-Simcoe, Newmarket-Aurora, Haliburton-Kawartha Lakes-Brock and Durham, and to all the Lake Simcoe Region municipalities and the LSRCA (Item for Discussion, 8.3, April 4, 2022)

Motion 10.3 - Councillor Thompson; Re: Mandatory Firefighter Certification

Please be advised that this matter was considered by Council at its meeting held on May 24, 2022, and in this regard, Council adopted the following resolution:

Whereas municipal governments provide essential services to the residents and businesses in their communities; and

Whereas the introduction of new provincial policies and programs can have an impact on municipalities; and

Whereas municipal governments are generally supportive of efforts to modernize and enhance the volunteer and full-time fire services that serve Ontario communities; and

Whereas the Association of Municipalities of Ontario (AMO) believes in principle that fire certification is a step in the right direction, it has not endorsed the draft regulations regarding firefighter certification presented by the Province; and

Whereas municipalities and AMO are concerned the thirty-day consultation period was insufficient to fully understand the effects such regulations will have on municipal governments and their fire services; and

Whereas fire chiefs have advised that the Ontario firefighter certification process will create additional training and new costs pressures on fire services; and

Whereas the Ontario government has not provided any indication they will offer some form of financial support to deliver this service; and
Whereas AMO, on behalf of municipal governments, in a letter to Solicitor General Jones dated February 25, 2022, made numerous comments and requests to address the shortcomings in the draft regulations;

1. Now Therefore Be It Hereby Resolved That the Town of Aurora does hereby support AMO's recommendations; and
2. Be It Further Resolved That the Town of Aurora does hereby call on the Solicitor General of Ontario to work with AMO, municipal governments and fire chiefs across Ontario to address the concerns raised so that municipalities can continue to offer high quality services to their communities; and
3. Be It Further Resolved That a copy of this Motion be sent to the Association of Municipalities of Ontario (AMO), the Ontario Small Urban Municipalities (OSUM), and all Ontario municipalities for their consideration.

The above is for your consideration and any attention deemed necessary.

To all Ontario municipalities:

At its meeting held on June 6, 2022, Orillia City Council adopted the following resolution:

“THAT the correspondence dated April 19, 2022 from the Town of Gravenhurst regarding sanctions on Russia be received;

AND THAT the City of Orillia supports the sanctions related to Russia that have been enacted under the Special Economic Measures Act in order to respond to the gravity of Russia’s violation of the sovereignty and territorial integrity of Ukraine, and grave human rights violations that have been committed in Russia;

AND THAT the City of Orillia supports the sanctions related to Belarus that have been enacted under the Special Economic Measures Act in response to the gross and systematic human rights violations that have been committed in Belarus, as well as Belarus’ support of the Russian Federation’s violation of the sovereignty and territorial integrity of Ukraine, which constitutes a grave breach of international peace and security that has resulted in a serious international crisis;

AND THAT this decision of Orillia Council be forwarded to all other municipalities within Ontario requesting they enact similar measures so that as a united front we can make a noticeable difference.”

WHEREAS silence is complicity;

WHEREAS Canada imports hundreds of millions of dollars' worth of goods from Russia each year; and

WHEREAS negative financial impacts upon a country can be used as a means to deter further conflict;

BE IT RESOLVED THAT the correspondence received from the City of Thorold, the Town of Gravenhurst, the Town of Espanola and Niagara Region regarding sanctions on Russia be received for information;

AND THAT the Municipality of Killarney unequivocally denounces Russia's unjustifiable war against Ukraine;

AND THAT the Municipality of Killarney supports the sanctions which the Federal Government of Canada has thus far imposed on Russia;

AND THAT effective immediately and until a time when the sovereignty of Ukraine is once again unchallenged, the Municipality of Killarney will:


- 1) Not purchase any products (i.e. plywood, fertilizer, steel, furniture or machinery) which can be easily traced to have originated from Russia; and
- 2) Insist that any future contracts for services for the Municipality of Killarney abide by these same limitations within our municipality;

AND THAT upon confirmation that the Belarusian military is engaged within Ukraine that the Municipality of Killarney apply these limitations upon goods from that country as well;

The Cannabis Cultivation and Production Regulatory Study was initiated by the Town of Whitchurch-Stouffville to prepare a land use planning framework to regulate the legal cultivation and processing of recreational Cannabis. A Public Open House and a presentation to Council for information purposes were previously held to consult with the public on the Study. The Study has resulted in a recommendation for an Official Plan Amendment and an implementing Zoning By-law Amendment.

THE PURPOSE AND EFFECT of the proposed amendment to the Town's Official Plan and Zoning By-law would establish a land use planning framework to regulate lands legally used for the cultivation and processing of recreational Cannabis within the Town.

The Town-initiated Official Plan Amendment proposes to amend the Town's Official Plan to:

- Amend the Agricultural land use designation and certain Employment land use designations established by the Official Plan to legally recognize Cannabis Cultivation and Cannabis Processing as permitted uses, subject to certain criteria.
- Establish specific policy criteria applicable to Cannabis Cultivation and Cannabis Processing to mitigate land use conflict and incompatibility with more sensitive land uses, and recognize the Town's natural environment system, including lands subject to the Oak Ridges Moraine Conservation Plan.
- Introduce definitions for Cannabis Cultivation and Cannabis Processing.

The Town-initiated Zoning By-law Amendment proposes to amend the Town's Zoning By-law to:

- Amend certain zones that permit agricultural and employment land uses to recognize Cannabis Cultivation and Cannabis Processing as permitted as-of-right.
- Updating definitions for Cannabis Cultivation and Cannabis Production.
- Establish specific standards, including lot and building requirements, applicable to Cannabis Cultivation and Cannabis Processing land uses.

- Establish provisions to mitigate land use conflict and incompatibility from more sensitive land uses, while recognizing the Town's natural environment system, including lands subject to the Oak Ridges Moraine Conservation Plan.

Any person may attend the Council Public Meeting in person or electronically and make written and/or verbal representation either in support of or against the Official Plan Amendment and Zoning By-law Amendment Application. Appeal Procedure:

If a person or public body would otherwise have an ability to appeal the decision of the Town of Whitchurch-Stouffville to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Whitchurch-Stouffville before the proposed Official Plan Amendment and Zoning By-law Amendment is adopted or by-law is passed, the person or public body **is not entitled to appeal the decision** of the Council of the Town of Whitchurch-Stouffville to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Town of Whitchurch-Stouffville before the proposed Official Plan Amendment and Zoning By-law Amendment is adopted or by-law is passed, the person or public body **may not be added as a party to the hearing of an appeal** before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

Passage of The Regional Municipality of York Development Charges Bylaw

Thursday, June 2, 2022

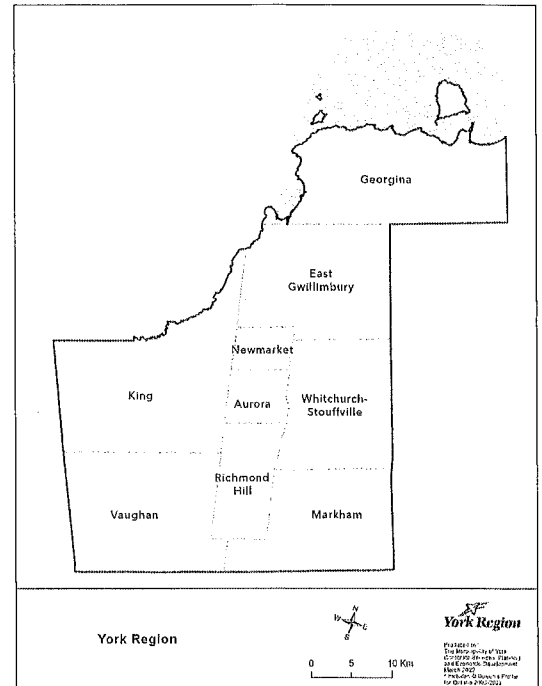
On Thursday May 26, 2022, York Regional Council passed *Development Charges Bylaw No. 2022-31*, which will come into effect on Friday, June 17, 2022.

Development charges are fees collected on new residential and non-residential development and are the primary source of funding for growth-related infrastructure. The purpose of *Development Charges Bylaw No. 2022-31* is to help fund growth-related capital costs for hard services (water, wastewater and roads) and general services (Yonge North Subway Extension, Toronto-York Spadina Subway Extension, transit, police, waste diversion, public health, public works, ambulance services, housing services, court services, long-term care/seniors services and growth studies).

Development Charges Bylaw No. 2022-31 will apply to all lands in The Regional Municipality of York, with the exception of those wastewater services in the Village of Nobleton, currently recovered under Bylaw No. 2021-34. The map illustrates the location to which *Development Charges Bylaw No. 2022-31* applies.

The new development charges rates, under *Development Charges Bylaw No. 2022-31*, will apply to residential and non-residential development and are as set out in the table below.

Re: Summary and Implications of Provincial Bill 109: More Homes for Everyone Act, 2022

For your information and records, at its electronic meeting held on June 7, 2022 the Council of the Town of East Gwillimbury enacted as follows:

WHEREAS the Town of East Gwillimbury is Canada's fastest growing municipality (with more than 5,000 residents) according to 2021 Census Canada data; and

WHEREAS the Council of the Town of East Gwillimbury has significant concerns regarding the impact of Bill 109 on the community planning process, and the ability of municipalities to deliver on initiatives to address housing supply and attainability, and

WHEREAS the refund provisions in Bill 109 will result in existing taxpayers subsidizing development applications as well as lost revenue and increased staff costs for municipalities; and

WHEREAS the prescription of what constitutes a complete application does not address differing levels of complexities and the unique circumstances and diverse landforms that exist across the province, nor does it recognize the collaborative process and relationships between parties that deliver results for municipalities; and

WHEREAS limiting conditions on Draft Plan of Subdivision does not address the unusual and often challenging circumstances best understood by local municipal staff and elected officials;

BE IT THEREFORE RESOLVED THAT the Council of the Town of East Gwillimbury requests that Government of Ontario revisit the provisions of Bill 109 and work with all stakeholders, including municipalities represented by the Association of Municipalities of Ontario to deliver legislation that allows municipalities to plan, grow and deliver communities that adhere to local, provincially-approved Official Plans, rather than strict statutory timelines; and

THAT a copy of this Motion be sent to the Honourable Doug Ford, Premier of Ontario, MPP Caroline Mulroney, the Minister of Municipal Affairs and Housing, all York Region Mayors and Regional Chairs in Ontario; and

THAT a copy of this Motion be sent to the Association of Municipalities of Ontario (AMO) and all Ontario municipalities for their consideration.

OHRC presents first-ever Daniel G. Hill Human Rights Awards

Today, on the 60th anniversary of the enactment of Ontario's Human Rights Code, in a YouTube premiere, the Ontario Human Rights Commission (OHRC) presented the first-ever Daniel G. Hill Human Rights Awards, and honoured four recipients who have each made significant contributions to advance human rights in Ontario and beyond.

The awards are named after Daniel G. Hill, who was the first director and first Black chair of the OHRC. Dr. Hill was one of the earliest human rights visionaries, who set a solid legacy that still resonates today.

Awards were given in three categories. The Young Leaders award was presented to Autumn Peltier, who is Anishinaabe-kwe, and a member of the Wiikwemkoong First Nation. She is a water protector who began her fight for Indigenous Canadians' right to clean drinking water when she was eight years old. Now 17, she has campaigned for water protection around the world. She is one of the leading youth changers in the world today, and is an inspiration to young people and people of all ages.

The Distinguished Service award was presented to Rabia Khedr, who has worked for over 30 years to advance disability rights. She consistently breaks barriers and changes perceptions with her vast knowledge and experience, and is a tireless community organizer who continues to reimagine ways one person can be the start of something big in advancing human rights.

The first of two Lifetime Achievement awards was presented to Kim (Brooks) Bernhardt, who began her human rights legacy at the genesis of the OHRC, when she accompanied her parents to meetings where key citizens like Louis Fine and Daniel G. Hill met to strategize to lobby the government to create the Commission. She has served Ontario's communities as a child, as a student, as a lawyer, an advocate, a teacher, a community partner, and most importantly, as a friend with vision and leadership to the benefit of communities across Ontario. Her work has ranged from setting up a strategic plan for anti-

racism organizational change at the Ontario Nurses' Association to playing a pivotal role in the major 2008 amendments to the Human Rights Code.

A Lifetime Achievement award was also presented to David Lepofsky. A lawyer who is blind, David has spent much of his career supporting Ontarians with disabilities, and is recognized across Canada as a disability/accessibility leader. Among his many accomplishments, David was instrumental in winning two important cases against the Toronto Transit Commission to create audible and visual transit stop announcements – an innovation that has been adopted beyond Ontario to other parts of Canada and even other countries. He also played a key advocacy role in the Accessibility for Ontarians with Disabilities Act (AODA) becoming law in June 2005, and continues to challenge the landscape for people with disabilities in Ontario.

The OHRC received dozens of nominations, and choosing recipients was very challenging because there were so many deserving candidates. A special committee, which included members from the OHRC's Community Advisory Group, reviewed and short-listed the nominations, and the OHRC Commissioners made the final decision.

"The Dr. Daniel G. Hill awards are just a small showcase of how the work of people across Ontario is positively transforming the human rights landscape," said Chief Commissioner Patricia DeGuire. "I say thank-you to the myriad people and organizations across Ontario who continue, every day, to promote and reimagine human rights – a veritable tool in maintaining peace, order, and good government in Ontario."

Aujourd'hui, à l'occasion du 60e anniversaire de la promulgation du Code des droits de la personne de l'Ontario, la Commission ontarienne des droits de la personne (CODP) a présenté, en première sur YouTube, les tout premiers Prix Daniel G. Hill pour la promotion des droits de la personne et a rendu hommage à quatre lauréats qui ont tous contribué de façon importante à l'avancement des droits de la personne en Ontario et ailleurs.

Ces prix portent le nom de Daniel G. Hill, qui a été le premier directeur et le premier président noir de la CODP. M. Hill, qui comptait parmi les premiers visionnaires des droits de l'homme, a laissé un héritage considérable qui perdure encore aujourd'hui.

Trois catégories de prix ont été décernées. Le prix Jeunes leaders a été remis à Autumn Peltier, qui est Anishinaabe-kwe et membre de la Première Nation Wiikwemkoong. Protectrice de l'eau, elle a commencé à se battre pour le droit des Canadiens autochtones à disposer d'eau potable à l'âge de huit ans. Aujourd'hui âgée de 17 ans, elle a fait campagne pour la protection de l'eau dans le monde entier. Elle compte parmi les jeunes qui changent les choses dans le monde d'aujourd'hui et est une source d'inspiration pour les jeunes et les personnes de tous âges.

Le prix Services exceptionnels a été décerné à Rabia Khedr, qui travaille depuis plus de 30 ans à la promotion des droits des personnes handicapées. Elle fait constamment tomber les barrières et évoluer les mentalités grâce à ses vastes connaissances et à son expérience. Organisatrice communautaire infatigable, elle continue à imaginer comment une personne peut être à l'origine de quelque chose de grand pour faire avancer les droits de la personne.

Le premier des deux prix Ensemble des réalisations a été décerné à Kim (Brooks) Bernhardt, qui a débuté son parcours en matière de droits de la personne à la genèse de la CODP, lorsqu'elle a accompagné ses parents aux réunions où des citoyens clés comme Louis Fine et Daniel G. Hill se sont rencontrés pour élaborer une stratégie afin de faire pression sur le gouvernement pour créer la Commission. Elle a servi les communautés de l'Ontario en tant qu'enfant, étudiante, avocate, défenseure, enseignante, partenaire communautaire et, plus important encore, en tant qu'amie faisant preuve de vision et de leadership au profit des communautés de l'Ontario. Son travail va de la mise en place d'un plan stratégique de changement organisationnel antiraciste à l'Association des infirmières et infirmiers de l'Ontario à un rôle central dans les modifications majeures apportées au Code des droits de la personne en 2008.

Un prix Ensemble des réalisations a également été décerné à David Lepofsky. Avocat aveugle, David a consacré une grande partie de sa carrière à soutenir les Ontariens handicapés et il est reconnu dans tout le Canada comme un chef de file en matière de handicap et d'accessibilité. Parmi ses nombreuses réalisations, David a joué un rôle déterminant dans le gain de deux importantes causes contre la Toronto Transit Commission, afin de créer des annonces sonores et visuelles des arrêts de transport en commun - une innovation qui a été adoptée au-delà de l'Ontario, dans d'autres régions du Canada et même dans d'autres pays. Il a également joué un rôle clé dans l'adoption de la Loi sur l'accessibilité pour les personnes handicapées de l'Ontario (LAPHO) en juin 2005, et il continue de défier le paysage des personnes handicapées en Ontario.

La CODP a reçu des dizaines de candidatures, et le choix des lauréats a été très difficile en raison du grand nombre de candidats méritants. Un comité spécial, comprenant des membres du groupe consultatif communautaire de la CODP, a examiné et présélectionné les candidatures, et les commissaires de la CODP ont pris la décision finale.

« Les prix Dr Daniel G. Hill ne sont qu'une petite vitrine de la façon dont le travail des gens de tout l'Ontario transforme positivement le paysage des droits de la personne », a déclaré la commissaire en chef Patricia DeGuire. « Je remercie la multitude de personnes et d'organisations de l'Ontario qui continuent, chaque jour, à promouvoir et à réimaginer les droits de la personne - un véritable outil pour maintenir la paix, l'ordre et le bon gouvernement en Ontario. »

Whereas the Ontario Amber Alert is a warning system that quickly alerts the public of a suspected abduction of children who are in imminent danger;

And Whereas the goal is to broadcast as much information about the child, the abductor and suspect vehicles as quickly as possible so that the public can respond with any relevant information that might lead to the child's safe return;

And Whereas people are encouraged to share the Amber Alert with as many people as possible. If a child or vulnerable person is abducted, spreading the information quickly is critical to their safe return;

And Whereas an Amber Alert makes the Public aware to keep an eye out for the child, vulnerable person, suspect and the vehicle described, in the alert. If they spot them, try to gather as many details as they can, including the specific location where they saw them, the time, the direction they were travelling in and any other identifying details that will help to locate them;

And Whereas an Amber Alert gives citizens instructions to call 9-1-1 or the phone number included in the alert immediately if they have a trip or a sighting related to an Amber Alert;

An Amber Alert will only be activated if:

- The police have confirmed that an abduction has taken place; and
- There is reason to believe the victim is in danger of serious physical injury, and there is information available that, if broadcast to the public, could assist in the safe recovery of the victim.

And Whereas it is essential to remember that an Amber Alert is not always appropriate in every circumstance and that their continued effectiveness depends on ensuring that they are only used in cases that meet the above criteria;

And Whereas the recent tragic death of 11 year old Draven Graham showed that the Amber Alert system is flawed when it comes to vulnerable children who can go missing but are not abducted;

And Whereas at the time this motion was written, there have been almost 75,000 citizens who had signed a petition on Change.Org requesting that a Draven Alert be created;

And Whereas it is clear that there needs to be an addition to the alert system to allow for law enforcement to send out an alert for vulnerable children who go missing under circumstances that do not involve an abduction but are at serious risk of injury or death;

Therefore be it resolved that the Municipality of Brighton and its Council endorse the following:

1. That the Minister of the Solicitor General and the Commissioner of the Ontario Provincial Police, as well as the Premier's Office, be requested to make the necessary changes to the Amber Alert system and create a new alert called the Draven Alert, which will protect vulnerable children who have not been abducted but are at high risk of danger, injury or death and alert the public that they are missing.
2. That this motion be sent to all municipalities across Ontario and the Association of the Municipalities of Ontario (AMO) for endorsement.

WHEREAS Ontario Regulation 380/04: Standards under the Emergency Management and Civil Protection Act sets the municipal standards for emergency management programs in Ontario and requires municipalities to conduct an annual exercise with their Emergency Control Group in order to evaluate the municipality's emergency response plan and procedures, O. Reg. 380/04, s. 12(6);

AND WHEREAS Emergency Management Ontario previously granted municipalities exemption for the annual exercise requirement when the municipality experienced an actual emergency with documented proof of the municipality actively engaging their emergency management procedures and plan in response to the emergency;

AND WHEREAS on August 5, 2021 the Chief, Emergency Management Ontario (EMO) issued a memo to Community Emergency Management Coordinators stating that effective immediately, the Chief, EMO would no longer be issuing exemptions to the O. Reg. 380/04 requirements to conduct an annual exercise;

AND WHEREAS municipalities experience significant costs and burden to staff resources when faced with the response to an actual emergency and activation of their Emergency Control Group and/or Emergency Operations Centre;

AND WHEREAS a municipality's response to an actual emergency is more effective than an exercise in evaluating its emergency response plan and procedures as mandated by O. Reg. 380/04;

The purpose and effect of the Zoning By-law Housekeeping Amendment (File No. ZBA22.004) is to make housekeeping and technical amendments to the Town's Comprehensive Zoning By-law 2010 -001-ZO Section 3, Section 7 and Section 9 as follows: Section 3.6.2 is amended to include clarification on open sports courts, Section 3.22 is amended to clarify the maximum projections into the required yards, Section 3.27 is amended to remove food preparation services from prohibited uses under Home Occupations, Section 3.31 is amended to include open sports courts to exclude from the lot coverage calculations and Section 3.33.1 is amended to include a regulation for location of Temporary Property Sales Centre; Section 7.1.1 is amended to update a Qualifying Note; Section 9 is amended to revise the definition of "Restaurant, Take Out", delete the definition of "Services of Sexual Nature" and revise the definition of "Adult Entertainment Establishment".

All written submissions received by the Town of Whitchurch-Stouffville were considered in the making of this decision.

- iv. In addition, pursuant to By-law No. 2021-112-FI, a processing fee of \$251 per Ontario Land Tribunal (OLT) appeal, payable to the Town of Whitchurch-Stouffville, is required to be paid at the time of filing a Notice of Appeal.

However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Ontario Land Tribunal, there are reasonable grounds to add the person or public body as a party.

This year marks the 230th anniversary of the remarkable Black Loyalist exodus from Halifax to Freetown. This journey is the single, largest return of African descendants to the continent of Africa throughout history. **Please join 230 mayors and councils from across Canada to acknowledge this 230th anniversary year by proclamation and/or social media.** We acknowledge the importance of your leadership for community and change, and respectfully request your support for this initiative.

#1792Project began in Nova Scotia. The story of the 15 Ships to Sierra Leone departing Halifax harbour on January 15, 1792, is not only a Maritime story. This voyage has had an impact on all of Canadian society. Together we can address this omission in our history books to reach a fuller understanding of the history of slavery and race in this nation. Over 25 municipalities have issued proclamations in Nova Scotia and the town of Shelburne leads this initiative of cross Canada Proclamations.

Black Loyalists were self liberated individuals who came to Nova Scotia after the American Revolution, as did the white Loyalists who brought with them an estimated 1,232 slaves.¹ Broken promises of land and liberation together with remarkable courage to cross the ocean at the height of the trans-Atlantic chattel slave trade remains an untold story of resilience of the 1,196 seafarers who chose to leave. But it is also a story of failure of community and government to provide safe haven here on these shores for these Black Loyalists. Through participation and education we must all do better to connect the history of failures to how the legacy of this history continues.

We, the [#1792Project](#) team, are community members, students and educators and we have come together in the imperative of sharing, commemorating and acknowledging this story through education. How can we make a difference as a grassroots effort?

Whereas we proclaim the 230th anniversary of 15 ships departing the harbour of Halifax in 1792, and that the conditions and causes that led to the exodus of 1,196 self liberated Black Loyalist were conditions of abject institutionalized racism and that this departure took place at the height of the transatlantic chattel slave trade, one of the cruelest chapters in the history of humanity.

Whereas the recognizes that people of African descent have been a part of Canadian society since the early 1600s and that their enslavement occurred on this land for centuries and that the Black Loyalists departure is linked to the failure of institutional, political and societal will to fulfill the promises that were made to the communities that left for Sierra Leone.

Whereas is committed to promote histories such as the 15 Ships to Sierra Leone that often have been left in a vacuum of erasure throughout Canada. The resources provided for well known monumentation have historically been funded at the expense of those erasures.

Whereascontinues to recognize the ongoing significance of the UN Decade of African Descent and the importance of recognizing the history of Black Loyalists in Nova Scotia and throughout Canada. We recognize that rural or urban, from sea to sea we share a responsibility for reparation.

Whereas we recognize that secure housing and land was promised to these early settlers and very few [received what was owed](#). Despite petitions ([by Thomas Peters](#))the promised land and supplies were not provided . For many Black Loyalists, shared Mi'kmaq knowledge was key to survival in the first winters. Reparations for injustice is the path forward.
